

Introduction to Drugs and Cosmetics Rules, 1945



• Established to regulate the import, manufacture, distribution, and sale of drugs and cosmetics.



 Ensures safety, efficacy, and quality of medicines.



What is Rule 65?

 Specifies conditions for selling drugs under a license. Includes storage, record-keeping, prescription requirements, and compliance.

General Conditions for Sale of Drugs

- Display the Original License
 Only licensed dealers can sell drugs.
- Certain drugs require prescriptions.
- Proper records must be maintained.



Requirements for Retailers

- A valid drug license is mandatory.
- License must be displayed prominently.
- Sales should be supervised by a registered pharmacist.



Storage and Handling of Drugs

- Maintain prescribed temperature conditions.
- Separate storage for prescription and non-prescription drugs.

Store Veterinary Drugs and Expired Drugs Seperatly

 Proper stock rotation to prevent expired drugs.



Prescription Drugs (Schedule H, H1, X)

- Schedule H/H1 drugs require a prescription.
- Schedule X drugs have stricter regulations.
- Sale records must be maintained.
 Issue of sale Bills compulsory and maintenance of Duplicate Bills



Record-Keeping for Prescription Drugs

- Maintain prescription copies for Sch-X Drugs
- Record patient details for Schedule H1 drugg

Maintain Purchase invoices in Chronological order.

Put Dispensed seal on Prescription.

Do not Substitute.

Proper documentation helps in audits.

Check the Labeling and Packaging Regulations



 Drugs must have proper labels.



Explain to the Patients about Label Restrictions



 Labels must include composition, expiry, batch number.



 Tamper-proof packaging for certain drugs like thyroxine Tablets and Pre-Filled
 Syringes.

Sale of Over-the-Counter (OTC) Drugs

- Can be sold without a prescription.
- Retailers should educate customers on proper usage.
- Avoid over-promoting self-medication.

Do not sold Sch -Drugs without Proper Prescription.

Banned and Restricted Drugs

Selling banned drugs is illegal.Information is
 Notified by CDSCO under Section 26A by Gazette

Always check the updated banned drug list.

Latest Notification by Govt of India Dated:20-2-2025 regarding Prohibition of Mnufacture and sale of "Nimesulide and it's formulations" for Veterinary Use

Dispensing of Narcotic and Psychotropic Substances

- Requires special permission from authorities for sale of Drugs like Morphine, Pentenyl
- Strict record-keeping is necessary.

Non-compliance leads to severe legal action.

Sch-X Required prescription in Duplicate

Inspection and Compliance

Drug inspectors conduct routine checks.

Maintain Form-35

- Maintain proper records and licenses.
- Any violations can lead to penalties or license cancellation.
- If Drugs sold Less than the MRP there is no Violations.

Penalties for Non-Compliance

- Violation of Section 18 and Rule 65
 Offence Under Section 27
 Heavy fines and imprisonment for violations.
- License suspension or cancellation.
- Always follow legal regulations to avoid issues.

Recent amendments Provide provision for compounding of Offences (Vide notification 10-7-2024)

Patient Safety and Ethical Practices

• Dispense drugs as per prescription.

Educate patients on dosage and side effects.

Patient counselling

 Avoid selling habit-forming medicines without proper prescriptions.

Don't Dispense in absence of Pharmacist.

Recent Amendments and Updates

- New rules to be introduce on electronic prescriptions.
- Stricter regulations on Schedule H1 drugs.
- Stay updated with regulatory changes.
